

PLAYGROUP WA (INC) Join Playgroup Early Bird Competition 2026 TERMS AND CONDITIONS

- 2. The Competition begins when Playgroup WA registrations open for 2026, on 1 December 2025 (Australian Western Standard Time) and ends on 2 March 2026 at 9:00am (Australian Western Standard Time) (Competition Period). Some prizes will be drawn prior to the end date; details provided in these Terms and Conditions.
- 3. To be eligible, entrants must be current 2026 Playgroup WA members at the time of the prize draw, which includes registering and paying the Playgroup WA membership fee via the Playgroup WA membership portal.
- 4. The Promoter reserves the right to either allow or disallow any entrant for any reason it sees fit in its absolute discretion.
