

PLAYGROUP WA (INC) 'Early Bird Competition 2021' Promotion TERMS AND CONDITIONS

- The promoter of the 'EARLY BIRD COMPETITION 2021' Promotion is Playgroup WA (Inc) ABN 14 415 755 273 (the Promoter).
- The Competition begins on 1 January 2021 at 12.00am (Australian Western Standard Time) and ends on 19 March 2021 at 5.00pm (Australian Western Standard Time) (Competition Period).
- Entries must be received by the Promoter during the Competition Period
- 4. To be eligible for the prizes the entrants must have joined and had their payment processed to become a current or new member of a Playgroup WA (Inc) registered playgroup between the Competition dates 1 January 2020 at 12:00am (Australian Western Standard Time) and 19 March 2021 at 5.00pm (AWST).
- The Promoter reserves the right to either allow or disallow any entrant for any reason it sees fit in its absolute discretion.
- Entry to the Competition is not open to employees of Playgroup WA (Inc).

 - b. any theft, unauthorised access or third party interference;

 - e. any tax liability incurred by a winner or entrant; or
